2022 – The year European aviation bounced back, despite war & Omicron/COVID

Aviation Intelligence Unit Performance 2022 – Outlook 2023

From a slow start at around 70% of pre-pandemic traffic as a new wave of COVID triggered restrictions, and despite the shock of Putin's brutal invasion of Ukraine which closed airspace and affected traffic flows, from March 2022 onwards European air traffic began a steady climb back to the high 80%s, levels maintained ever since – although the global numbers conceal wide traffic variation across airlines, airports, ANSPs and States. In total, 2022 saw 9.3 million flights, 83% of 2019 traffic. That was 1.8 million fewer than2019, but 3.1 million more than last year. This Analysis Paper uses our unique network data to examine the state of the network as we head for 2023, in which we predict further strengthening to 92% of pre-COVID levels, but also huge challenges in terms of matching capacity with demand, and keeping delays down.



A lack of situational awareness with near tragic consequences



On 2 May 2015, an aircraft deviating very significantly north of its normal route from Malabo to Douala at night because of convective weather had just turned towards Douala very close to 13,202 feet high Mount Cameroon whilst descending through 5000 feet, when an EGPWS TERRAIN AHEAD alert and 'PULL UP' warning prompted an 8,000 foot climb which passed within 2,100 feet of terrain when close to and still below the summit. The Investigation attributed the dangerous event primarily to a absence of the augmented crew's situational awareness and the operator's failure to risk-assess the route involved.


Incorrect QNH Selection





On 6 June 2020 a Boeing 787-10, performing the RNP-Y approach for runway 31L at Abu Dhabi (OMAA), using standard QNH 1013 instead of actual QNH 999, descended below the approach vertical profile. The aircraft descended to 210 feet AGL, 1.3 NM from the runway threshold, approximately 350 feet below the surrest elititude approach profile when the flight descended to 210 feet AGL, 1.4 NM from the runway threshold, approximately 350 feet below the correct altitude, according to the approach profile, when the flight crew acquired the PAPI, indicating 4 red, and initiated a go-around.
